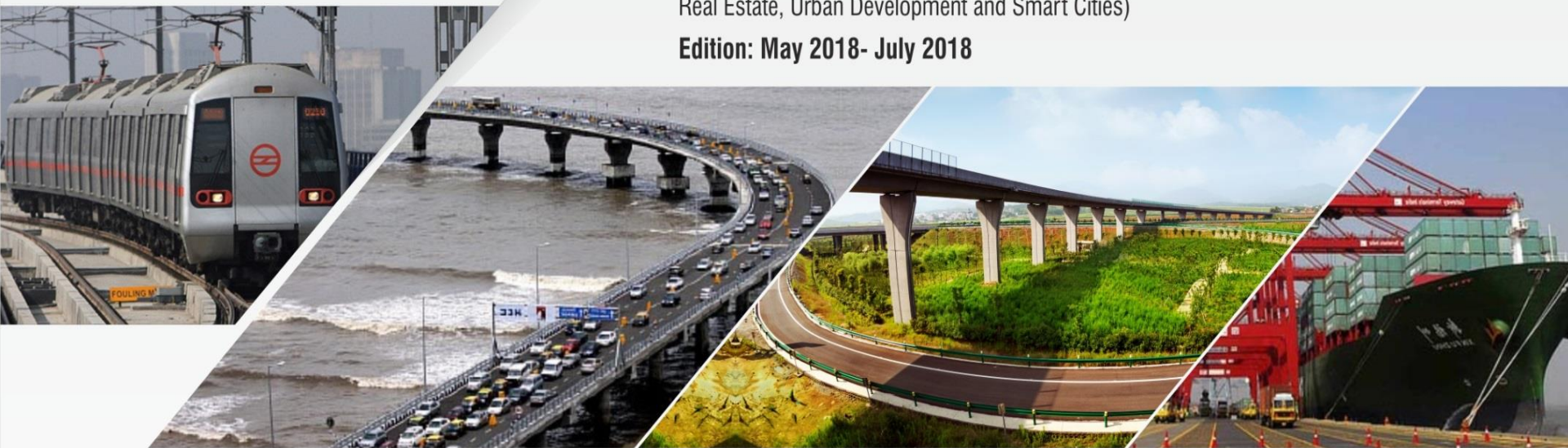

Improving Transparency in Secondary Real Estate Market

20 July 2018, FICCI, Federation House, New Delhi

FICCI organised a conference on “Improving Transparency in Secondary Real Estate Market” on 20 July 2018 at Federation House, New Delhi. FICCI POLICY RECOMMENDATION

- **Aviation Turbine Fuel (ATF) supply at Mumbai Airport:** FICCI welcomed the initiative of Petroleum and Natural Gas Regulatory Board (PNGRB) on declaring the ATF pipelines currently owned and controlled by BPC and HPC as “common carrier”, and bringing them under the applicable regulations. The same was put forward towards the Ministry of Civil Aviation by FICCI after gathering inputs from our members.
- **Transporter’s strike:** FICCI has made a recommendation to the Ministry of Road Transport & Highways on taking necessary actions for curtailing the nation-wide strike by the All India Motor Transport Congress (AIMTC). The strike had taken a toll on the businesses of the various sectors in the economy. In view of the same, after receiving inputs from members and member associations, FICCI made a request to the ministry for a speedy intervention and resolution of the matter.
