

In a separate instance, Scottish Chambers of Commerce met officials at Department of Higher & Technical Education, Haryana to finalize terms of collaboration, discussion over which started in UK.

On trade and investment front, FICCI together with Government of India organized a high-powered business delegation to Vladivostok, Russian Far East in two parts. For the first, a total pool of 125+ business leaders accompanied Mr. Piyush Goyal, Hon'ble Commerce and Industry Minister and Chief Ministers of Haryana, Uttar Pradesh, Goa and Gujarat from August 11-13, 2019. About 12 delegates represented timber, healthcare, real estate, education and other sectors of Haryana in the visit. Some of these also went on to represent the State in Eastern Economic Forum i.e., second leg of delegation from September 04-06, 2019.

Apart from it, engagements in the domain of taxation, employability & industry-academia connect were also pursued. Major initiatives in agriculture and logistics, especially warehousing, are in pipeline. I look forward to share more on those in the next edition of North Chronicle.

SCOTTISH CHAMBERS OF COMMERCE MEETS HARYANA'S EDUCATION DEPARTMENT

July 22, 2019 | Chandigarh

FICCI Chandigarh facilitated an interaction between Department of Higher & Technical Education, Government of Haryana and Scottish Chambers of Commerce on July 22, 2019 in Chandigarh. Aiming at exploring global alliance in technical education, the interaction was a follow-up to the meeting held between said chamber and policy makers, education and academicians from Haryana as a part of FICCI's study delegation to UK from July 1, 2019 to July 6, 2019.

Mr. Ankur Gupta, IAS (Principal Secretary, Department of Higher & Technical Education, Haryana) and his team met delegation from Scottish Chambers of Commerce, led by Mr Tim Allen (President & Board Member) and comprising of Ms. Liz Cameron (Chief Executive & Director), Ms Poonam Gupta (Board Member) and Mr. Charandeep Singh (Deputy CEO), to deliberate over scope of academic-industry interface, education & skill development; entrepreneurship (incubation and acceleration); and bilateral trade between the education industries of Haryana and Scotland.

After careful discussion, both the parties agreed to develop industry-allied curriculum while benefiting from each other's expertise. It has also been decided that scope of Joint Research (with focus on industry concerns), alongside that of teachers training & students exchange programs, and student internships shall be identified for furthering the academic interest at both ends. FICCI Chandigarh shall act as a mediator between Department of Higher & Technical Education and Scottish Chambers of Commerce to track and facilitate weekly progress on the marked action points.

DELEGATES' PROFILE

MoU between Haryana and Russian Province for Trade and Investment Promotion

A Memorandum of Understanding (MoU) was signed between Mr. Manohar Lal Khattar, Chief Minister of Haryana and Mr. Aisen Nikolaev, Head-Russian Far Eastern Province of Sakha (Yakatukia).

Domain: Timber, Education, Real Estate, Healthcare among others

Sectors such as timber and plywood, oil & gas, agriculture & food processing, power, education & IT and healthcare & pharmaceutical were duly represented by 12 major industry players from Haryana, who accompanied Hon'ble Chief Minister, Mr. Manohar Lal Khattar on this delegation to represent the State in Vladivostok.

Delegates largely benefited from close interactions with local stakeholders in sector-specific session and B2B meetings that not only provided them a glimpse into market dynamics, but also enabled them to identify collaboration/partnership prospects for trade and business. Mr. Baljit Singh Khara (IRS), Assistant Director-NACIN, while addressing the participants during the course of workshop, stated,

"Goods and Services Tax (GST) is yet under evolution. Regular developments take place each passing day; painpoints are corrected and attempts are made to make it as industry-friendly as possible. But to ensure that it happens, it is important to hold regular interactions like this one, to map what works, note what doesn't and have a comprehensive feedback on what further could be done to make GST more and more feasible.

Intricacies of Sahaj, Sugam, Normal under New GST Returns were explained in the first session. Alongside, detailed discussion over GST ANX-1, preparation in GST Offline Tools and action steps at GST Portal was also witnessed.

In contnuance with the Session 1, Session 2 decoded GST ANX-2, GST RET-1, 2 & 3 and Legacy Dispute Resolution (LDS) Scheme 2019. Common concerns in GSTR-9 and GSTR-9C as well as issues in annual returns filing were addressed with Q/A round.

"New GST Returns will bring in transparency, compliance, simplify process and check on tax evasion", said Sanjay Malhotra, Indirect Tax Expert and Practicing Company Secretary. He was keynote speaker at a seminar in a city hotel here on Wednesday.

Federation of Indian Chambers of Commerce & Industry (FICCI) in association with strategic partner Tax and

Resolution Scheme-2019 in Goods and Service Tax".

He said, trials on new GST returns has started from July 2019 onwards for three months and taxpayers should make use of same. GST new returns implementation from October 1, 2019 will have one monthly return instead of

payment on monthly basis.
