Dear Readers,

COVID 19 pandemic has had an unprecedented impact on the economy impacting the industry and society. As we move from several phases of lockdowns and unlocks, the economy has slumped to an all time low of 23.9% compared to the growth of 3.1% in the previous quarter as per the recent data released by National Statistical Office (NSO). Most of the core manufacturing and services sectors are in the red with agriculture being the only sector showing positive growth. All this has its impact on jobs, placements, internships and apprenticeship and in turn impacts the future of our youth.

The education sector was the first to be closed under the lockdown and would be the last to open up. To mitigate this challenge several universities and colleges have moved into online mode of delivery but there are challenges of internet connectivity, access to device, training of faculty, content availability/development, assessments etc. Organizing common entrance exams for admissions into universities and colleges is also a challenge due to lack of capacities in various states and universities.

FICCI had initiated the discussion on Education 4.0 in 2018, a student centric approach, addressing the teaching-learning needs, knowledge and skill requirements of Industry 4.0. The proliferation of digital tools, applications and platforms has re-defined the teacher-learner interface, training pedagogies, instructional design and the mode of assessment and evaluation. In the post COVID times, hybrid models with blended learning will be the 'new normal'.

The first FICCI Eduwrap issue is being released in this backdrop. However, the special significance of the release is also due to the recently announced New Education Policy (NEP) 2020, that, if implemented in letter and spirit, is going to radically transform the educational landscape of the country. Apart from the editorial and featured articles, the Eduwrap also covers news items and reflections of national and global policy reforms, research and innovation, technology, skill requirements etc. We also have a specific section that talks about the recent FICCI initiatives/reports on higher education along with the forthcoming ones.

Through this newsletter, we have also consciously attempted to provide opportunity to universities and higher educational institutions (HEIs) to showcase their best practices, start-up activities and launch of new programs. Leader Speaks

The National Education Policy (NEP) 2020 has strongly attempted to streamline the existing Indian education system and bring about the requisite radical reforms that is in sync with the pressing needs and requirements of "future of education". The Policy has struck a proportionate balance by integrating the Indian education system with global trends and patterns on one hand, and instilling conviction and pride by highlighting that the rich heritage of ancient Indian Knowledge will be the guiding light of the policy, on the other hand. The policy very clearly has articulated that the rich Indian legacies must not only be nurtured and preserved but also researched and put to new uses through our education system.

The underlying principle of the policy is to create an enabling framework that helps in doing away with "rote-learning" and facilitates acculturation of an enquiry-based, project-led ecosystem of education that not only enhances the learning outcomes but also helps in rendering a more rounded and holistic development of individuals. There is a strong emphasis on promoting digitization, technology integration and its effective adoption to achieve the ambitious target of GER in higher education to 50% by 2035from the current 26.3%.

To deal with 21st century opportunities and challenges and with the rapidly evolving exponential technologies, the policy has focussed on developing an integrated liberal education endowed with multidisciplinary approach. It further envisions flexible curricular structures that will enable creative combinations of disciplines. While emphasizing on the need for liberal education, it clearly highlights the significance of liberal arts education that helps in developing all capacities of human beings in an integrated manner, viz intellectual, aesthetic, social, physical, emotional and moral. This is indeed a good move forward and FICCI commends the government for the same.

Further, for liberal education to be practiced in letter and spirit, one needs to move away from the shackles of regulatory rigidities and provide great amount of flexibility to Universities/HEIs.In this regard, the proposed single overarching regulatory body with the name National Higher Education Regulatory Council (NHERC) is a welcome step that will not only promote autonomy and flexibility but will also deter ambiguity from the ecosystem.

It needs to be highlighted that the Indian universitiesthat have been provided greater autonomy have demonstrated innovative approaches in adopting some of suggested changes mentioned in the new policy, especially with regards to integrating liberal education, flexible program structures with majors and minors, effective internship, etc. Government should encourage such universities and HEIs to handhold state universities in particular and other institutions in general, through a 'Mentor-Mentee relationship'. This wouldfurther lead to a collaboration amongst institutions (through "Hub and Spoke model), industry and optimal resource sharing.

The policy document prominently highlights the significance of Online and Distance Education (ODL) against the backdrop of the current Covid 19 pandemicand the compelling need to increase access and equity. To ensure efficient utilization of resources and to avoid unnecessary duplication of effort, the policy has indicated that all content developed for ODL will be included in an online digital repository. However, care needs to be exercised in ensuring that the IPR issues are adhered to, and are in line with the international best practices.

One of the other important aspects of this new policy that is set to fundamentally transform the research landscape of the country is the creation of a National Research Foundation (NRF) that intends to fund all kinds of research proposals having a strong bearing on nation's interest. NRF provides a level playing field as it will be open to both public and private sectors institutions. This is in line with FICCI recommendation to the government of creating a National Science, Humanities, and Technology Research Foundation akin to National Science Foundation (NSF) of USA.

While focussing on internationalization, the policy has taken care of some of the important elements that FICCI has also been suggesting the government in the recent past. However, it is important that the execution plan (that will be laid out through a legislative framework), should entail inter-ministerial collaborations to develop a conducive ecosystem that will encourage cross mobility of students, faculty and researchers, Indian institutions with foreign campuses and global institutions with campuses in India. Effective industry engagement with opportunities for apprenticeships and employment, safe and secure living environment, state of the art infrastructure, etc are some of the other critical pre-requisites that will not only boost international mobility of foreign students to India but will also develop India as a global destination of higher education.



Higher Education and Industry Partnerships During These Dynamically Changing Times

The world has spent the last few months reeling from the impact of a most unexpected event, the COVID-19 pandemic. At present, the crisis shows no signs of abating, but its impact has been clear and undeniable – lives have been lost, societies disrupted, and economies havetaken a sharp downturn. More than ever, individuals and societies are looking to leading organisations and institutions for guidance and support to help navigate an uncertain future.

COVID-19 was the first great disruptive event of the 21st century, but it is unlikely to be the last. Others are more like waves, and this includes forces such as climate change, resource sustainability, digitalisation, and the changing global order.

NUS is a strong proponent of how industry-academia partnerships can offer powerful opportunities in preparing, shaping and envisioning a more resilient and positive future. There are many possible areas of collaboration, but here, I would like to share just a few key examples.

In undergraduate learning and training, industry-academia partnerships can be a vital component in injecting greater relevance, as well as offering immersive and experiential learning experiences.

We have invited industry partners as Programme Advisory committee members to provide curriculum input; we are also moving strongly to expand our internships and apprenticeship programmes. At present, 70% of our students do an internship, and internships are compulsory for Engineering and Computing students, spanning 6 months. We have also launched co-operative programmes in cyber security, business analytics, and data science and analytics where we require 1.5 years of internships (within afour-year degree programme).

For our professional programmes, such as Law, Medicine, Dentistry, Nursing, Social Work and others, a practice or apprenticeship period has long been mandated as part of the curriculum.

One unique internship programme has become globally recognised — the NUSOverseas Colleges, which feature students in an extended internship in a technology-based start-up company in a global entrepreneurial hotspot, while continuing totake courseswith leadingpartner universities. These are sited in locations such as Silicon Valley and Stockholm, but also emerging places such as Ho Chi Minh City and Bandung.

These industry opportunities expose our students to real-world problem solving, and their accompanying complexities. They also promote positive traits like collaborative working, perseverance, and adjusting fluidly to circumstances.

Lifelong learning is another key area where industry-academia partnerships can deliver immense societal benefits. As people live longer, careers become more extended, and there is an urgent need for continuous training, to keep the labour force dynamic, as well as provide industry with workers who have relevant skills and experience.

At NUS, we have pivoted to make lifelong learning a centrepiece of our education framework, and launched the NUS Lifelong Learners or NUS L³ programme, which enrols every NUS student for 20 years from point of undergraduate admission. Our courses are focused on industry skills and needs, so that our 300,000 alumni can access a diverse suite of post-graduate programmes that enhance their life-time employability.

The challenges facing the world today are wide-ranging, complex and closely interrelated. Industry-academia partnerships can be instrumental in advancing cutting-edge research, as well as implementing robust, scalable solutions for broad community benefit.

At NUS, we offer the Corporate Labs scheme, which are public-private partnerships supported by the National Research Foundation (NRF). Partners include leading MNCs such as Wilmar International, Singtel and Keppel. These Labs undertake research and innovation in strategic areas such as water technologies, food sustainability and security, and data analytics and cyber security.

We also have extensive collaborations with other leading partners such as Microsoft, Grab and Capital Land Limited. These efforts undertake research in frontier domains such as data science, AI (with a specific focus onurban traffic), and sustainable urban living. In addition, such collaborations often include a talent development component, to nurture and seed talent within the relevant ecosystem.

Industry partners offer tremendous value in terms of having a clear area of focus, deep knowledge of markets and trends, and an orientation towards action and solutions. They're also often deeply committed to offering training, employment, and even entrepreneurial opportunities to a university's talent pool.




