The department of Health and Family Welfare Service is providing preventive, curative, promotive and rehabilitative health care majorly at primary and secondary level. The tertiary level of health care is given by the Medical College Institutions and Private or Corporate Hospitals.

These preventive and curative health care is provided to the people through 8870 sub-centers, located at small villages, 2310 Primary Health Centers, 180 Community Health Centers, 146 Taluka Hospitals and 17 District hospitals. The total strength of personnel involved in this yeoman service is 44,000. All the communicable diseases are prevented, controlled and specifically treated under various National Health Programmes. State specific communicable diseases are also taken care of.

With the advent of National Rural Health Mission, the reproductive, maternal and child health has received an exponential thrust to better service delivery towards reduction on MMR, IMR and increasing the 'institutional deliveries'. There is a vision to render services for the Non-Communicable diseases as well. The health care services are also taken to the doorstep of the people in highly inaccessible areas by the Health Assistants and now by the Mobile Health Clinics, which is a PHC on wheels.
