

Formation of standards is the need of the hour for technical textiles in the country. Standards of technical textiles are required for providing better hygiene, health care services, safety, sustainable environment and also for the inclusive growth of

Standards of technical textiles are required for providing better hygiene, health care services, safety, sustainable environment and also for the inclusive growth of the economy. Since technical textiles find applications in number of sectors like agriculture, industry, environment etc standardization of these products is important for the society as a whole.

- Technical Textiles are important as they are critical for health and hygiene, infrastructure development, social responsibility, security of nation and food security.
- Technical textiles is a high priority area and Government has taken many initiatives to support and develop this sector. Government has created eight Centers of Excellence (COE) to cater to the different areas of technical textiles on Meditex, Geotex, Agrotex, Protex, Nonwovens, Composites, Indutex and Sportex which are working in the area of standards also with BIS. Recently, Government has launched the Technology Mission on Technical Textiles (TMTT) for technology upgradation and to promote technical textiles in the country and formulation of standards for this sector is an important component of this mission.
- Lack of standards remain the biggest impediment for the technical textiles sector in the country. Usage of technical textiles in the country is restricted by non-availability of standards. Standards need to be formulated urgently for Meditex, Protex, Geotex, Buildtex, Agrotex, Nonwovens, Composites, Indutex and other segments. To brainstorm on these issues, FICCI, in partnership with Ministry of Textiles and Bureau of Indian Standards (BIS) is organizing a National Seminar on "Role of Standards in Promotion of Technical Textiles" on 30 November 2011. Mrs Rita Menon, Secretary, Ministry of Textiles will inaugurate the seminar.

Through this change over, the Government envisaged building of the climate of quality culture and conciousness and greater participation of consumers in formulation and implementation of National Standards. The Bureau of Indian Standards (BIS), the national standards body of India, resolves to be the leader in all matters concerning Standardization, Certification and Quality.
