

OVERVIEW

Safety of the workforce has to be the primary concern for all organizations and the community at large. Workers' safety and health needs to be at the heart of management process in manufacturing organisations.

While firms need to be competitive to ensure their financial health and long term sustainability, but the methods to achieve this need to be examined with the lens of safe and healthy work environment. Over the years there has been a greater degree of consciousness amongst Indian manufacturers with regard to safety at work place, but a lot more needs to be done and it has to be a dynamic process. Many firms in unorganised segment are still not much aware about good safety practices or do not have the means to implement it.

FICCI firmly believes that adopting a robust safety system is necessary condition for the progress of any responsible organisation. With this objective in mind, FICCI has instituted an award to recognise best safety and health system practices in manufacturing that provides learning for others.

ABOUT THE AWARD & CONFERENCE

After the successful completion of these Safety Awards for the last four years, FICCI launched the fifth edition of Safety Systems Excellence Awards in November 2015 that continue to focus on encouraging organisations to build strong safety systems. These awards are given to organizations in recognition of their work in the field of safety and health at the shop-floor with an emphasis on robustness of safety system. Applications were invited for these awards and several manufacturing units from sectors like Automotive, Capital Goods, Cement, Chemicals, FMCG, Food, Paper, Petroleum Refineries, Steel and Textiles applied this year.

In order to honour the best organisations in terms of safety systems, a conference is being organized that would also facilitate sharing of best safety practices at work place. The sessions would be conducted by safety experts from different sectors and the Award ceremony will be a part of the Conference. **Shri Anant G.
