

## About Awards

- ❖ Awards' focus is on recognizing robust quality systems in the industry
- ❖ Scope of the Awards:
  - Construction & Infrastructure
  - Manufacturing (including energy)
  - Mining
  - Power (including transmission, distribution and generation)



## Instructions

1. Applications for the awards:
  - ❖ For Manufacturing, Mining and Power sectors, application is for a single unit. But, multiple units of the same organization are eligible to apply for Awards.
  - ❖ For Construction & Infrastructure sectors, the application is for the organization and not for the individual project of the organization. However, in case of Ports and Airports, application of individual unit would be considered.
2. Category of the applicant unit for the awards & fees (non-refundable) will be determined by the category of the organization owning the unit (as per the categories defined below):
  - ❖ Small Size Organization (Organization having turnover & investment excluding working capital both less than Rs 100 crore)
  - ❖ Medium Size Organization (Organization having either turnover or investment excluding working capital between Rs 100 crore to Rs 500 crore. If any one of the parameter crosses the higher limit of Rs 500 crore then the organization is categorized as Large sized organization)
  - ❖ Large Size Organization (Organization having either turnover or investment excluding working capital more than Rs 500 crore)
3. Application fee for the Awards in three categories is as follows:
 

Rs. 17,250/- Small Size Organization inclusive of all taxes	Rs. 34,500/- Medium Size Organization inclusive of all taxes	Rs. 46,000/- Large Size Organization inclusive of all taxes

4. Application Fees should be sent through Cheque/DD in favor of "Federation of Indian Chambers of Commerce & Industry (FICCI)" payable at New Delhi.
5. Last date for receiving duly filled Application form in FICCI office is 30th September 2016
6. The evaluation is a three stage process as mentioned below:
  - ❖ Application evaluation
  - ❖ Onsite Audit for qualifying units after application evaluation (Please see application form for more details related to process and fees of audit).
  - ❖ Jury selection by the presentation of qualifying units after the audit.
