The Government of India had launched the Smart Cities Mission on 25 June 2015 with objective to promote sustainable & inclusive cities that provide core infrastructure and give a decent quality of life to its citizens, a clean and sustainable environment and application of 'Smart' Solutions. The idea is to look at compact areas, create a replicable model which will act like a lighthouse to other aspiring cities. The Smart Cities Mission is meant to set examples that can be replicated both within and outside the Smart City, catalysing the creation of similar Smart Cities in various regions and parts of the country.

Some of the core infrastructure elements in a Smart City would include adequate water supply, assured electricity supply, sanitation, including solid waste management, efficient urban mobility and public transport, affordable housing, especially for the poor, robust IT connectivity and digitalization, good governance, especially eticipation, sustainable environment, safety and security of citizens, particularly

Governance and citizen participation, sustainable environment, safety and security of citizens, particularly women, children and the elderly and health and education. Jaipur, Ajmer, Udaipur and Kota have been chosen from Rajasthan for development as Smart Cities.

Against this backdrop, Federation of Indian Chambers of Commerce and Industry (FICCI), in association with Department of Local Self Government, Rajasthan; Jaipur Municipal Corporation and Jaipur Smart City Ltd, is organising the 2nd Smart City Conclave on 16 March 2018 at ITC Rajputana, Palace Road, Jaipur, Rajasthan.

RETROSPECT



The first edition of Smart City Conclave was held on 21 May 2016 at Udaipur. It was organised by FICCI Department of Local Self Government, Government of Rajasthan; Udaipur Municipal Corporation and Udaipur Smart City Ltd. Theme Paper prepared by IICD Ltd was also released during the inaugural session.

Mr Rajpal Singh Shekhawat, Hon'ble Minister for UDH & LSG, Government of Rajasthan was the Chief Guest for the programme. Mr Gulab Chand Kataria, Hon'ble Minister for Home, Government of Rajasthan delivered the Presidential Address during the Inaugural Session of the programme. H E Mr Peter Taksoe Jensen, Ambassador, The Royal Danish Embassy and Mr Chandra Singh Kothari, Mayor, Udaipur Municipal Corporation were Guests of Honour for the conclave.

The first session focused on 'Greener and Healthier Cities'. It covered 'Sanitation for All by 2019' as outlined in the Swachh Bharat Mission as well as 'Integrated Solid Waste & Water Management'. The specific topics covered were : Udaipur Smart City Project, Smart Water Management, Sanitation for All, Waste Management for Smart Cities, Smart Cities – A Perspective from a Master Systems Integrator, and Integrated Water Resources Management Smart Approach for Smart Cities.

The second session focused on 'Smart & Vibrant Cities' covered 'Innovations and Technologies for Applications in Smart Cities'. The specific topics covered were: the Economics of Smart Cities, Smart Mobility, Use of ICT in Smart City Framework, Smart City Layers & Components – The Need for Horizontal Approach, and Conservation of Heritage Zones.

Ten Business to Government (B2G) meetings were also organized as a concurrent activity that included companies like CISCO, Wipro, IEEMA, L&T, Indus Towers, etc.
