In 2016 there were approximately 12,000 clinical laboratories and more than 22,000 diagnosis and therapy-related services in Brazil.



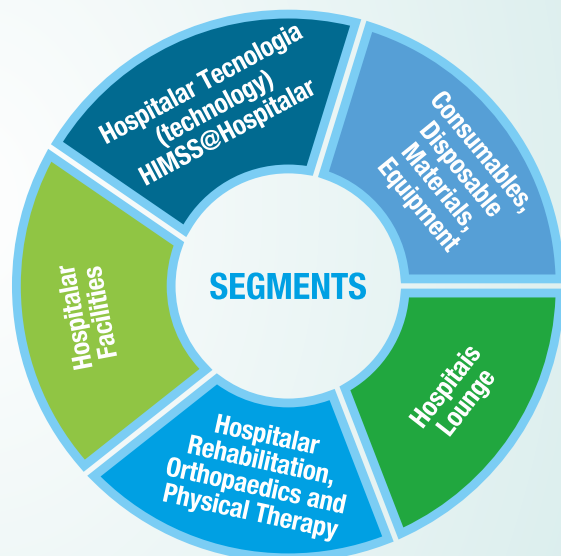
