Federation of Indian Chambers of Commerce & Industry (FICCI), Petroleum and Natural Gas Regulatory Board, Government of India, North Eastern Zonal Office, Tea Board of India and Government of Assam have joined hands in organising a Regional Conference on Occupational Health & Safety Management in North Eastern Region Industries (including Tea Industry) : Latest Technologies, Labour Law Reforms and Sustainability Issues on February 13-14, 2020 at Hotel Palacio, Guwahati, Assam.

**PNGRB** – Petroleum and Natural Gas Regulatory Board, India was established in 2007 subsequent to an Act of Parliament. The objectives of the board are to regulate refining, processing, storage, transportation, distribution, marketing and sale of petroleum, petroleum products & natural gas, excluding production of crude oil & natural gas. One of the functions of the Board is to regulate technical standards and specifications including safety standards. The board has notified several regulations such as technical standards and specifications including safety standards for natural gas pipeline networks and city or local natural gas distribution networks, codes of practice for emergency response and disaster management plan (ERDMP), etc.

**Chief Inspector of Factories, Government of Assam** - The functions of this Inspectorate involve multifarious activities contemplating the safety, health and welfare of the workers. This Inspectorate enforces labour legislations in the registered factories and protects the interest of the workers employed therein by effective implementation of safety and Health standards.

**North Eastern Zonal Office, Tea Board of India** - The North Eastern Zonal Office of the Tea Board in Guwahati is headed by Executive Director and there are 8 Regional Offices and 6 Sub-regional offices across all the North Eastern States which are being looked after by technical manpower to cater to the stakeholders of the tea industry. Given the special needs of the small tea growers a Small Growers Development Directorate has been set up in Dibrugarh. The mandate of the Tea Board is to improve productivity and quality, value addition, generic and brand promotion of made tea, collectivization of small tea growers into SHG and FPO, research through the Tea Research Association, training to small growers and welfare measures for workers that are supplementary to the Plantation Labour Act. The

Board is also carrying out regulatory activities. As per the recommendations of Niti forum for North East for implementation of Sector Specific Schemes, proposal for schemes on organic value chain, tea tourism, quality enhancement, brand building and warehousing have been drawn up.

**Federation of Indian Chambers of Commerce & Industry (FICCI)**, an apex industry association, has organized several training & education programmes in all major industrial sectors in coordination with accredited Indian and global agencies. Occupational Health & Safety Management in Industries (SMI), Sector has been selected by FICCI to raise awareness of Industries, Primary First Responders, District & State Authorities including Statutory Agencies as well as of all the stakeholders in the Community who are most vulnerable during emergencies.

The focus of the Regional Conference is to make North Eastern industry safe, manage their hazardous/toxic wastes and prepare for their onsite emergency management plans to minimize accidents. Codes on Wages, Occupational Safety, Health and Industry relations would also be discussed. The conference would also provide a platform to Indian companies to share their success stories, best practices, innovations and technologies to minimize accidents, occupational hazards occurring during manufacturing, production, operations, handling, storage, warehousing and transportation of Raw Material, Chemicals, Hazardous Wastes, Toxic Effluents, Gases etc.
